All individuals who own property located in a district where a separate school district exists are required to file a School Support Notification. Signatures of all registered property owners are required. If needed, please use an extra sheet to indicate the name, address, declaration and percentage of ownership of the additional registered property owners. If the property is jointly owned with a corporation, a Corporate School Support Notification must be completed for the corporation.

The Alberta Education Act (Section 146) provides:

- That individuals who declare that they are Roman Catholic must direct their taxes in support of schools to the Roman Catholic separate school district.
- That all other individuals must direct their taxes in support of schools to the public school district.
- Where two or more individuals (where one or more is Roman Catholic) own property, they must direct their taxes in support of schools to the Roman Catholic separate school district and the public school district in proportion to their ownership. Joint owners are deemed to own the property in equal shares, for example, two property owners, one Roman Catholic and the other one is not: 50% Separate, 50% Public; or three property owners all having equal shares, one Roman Catholic, and the other two are not: 33.3% Separate, 66.7% Public.

School Support Notification

FACT SHEET

- As the Constitution Act and the Alberta Act establishes Alberta's public and separate school systems on the basis of religion, school boards and tax collecting authorities are allowed and required to ask for the declaration contained in this form.
- In the Town of Diamond Valley, both a public and a Roman Catholic separate school district exist.
- When property is sold, the purchaser is required to file with the Town of Diamond Valley this School Support Notification.
- Property owners can at any time file a new School Support Notification or change an existing School Support Notification.
- A School Support Notification filed by a property owner is effective in the taxation year following the year in which the School Support Notification is filed.
- Individual property owners who are Roman Catholic must direct their taxes to the Roman Catholic separate school district.
- Individual property owners who are not Roman Catholic must direct their taxes to the public school district.
- Only property owners, not tenants, are entitled to file this School Support Notification.
- If property is owned by a Roman Catholic and a non-Roman Catholic, the municipality will assign the taxes to the public and Roman Catholic separate school districts in accordance with the percentage of ownership indicated beside the name of each owner.
- In order to ensure that property taxes are directed correctly, it is important that all property owners are designated on the School Support Notification and that the percentage of ownership adds up to 100%.
- If there is insufficient space to list all the registered property owners and to make the necessary declarations on the front of this School Support Notification, please use an extra sheet to indicate the name, address, declaration and percentage of ownership of the additional registered property owners.
- A School Support Notification is required for each titled property even if the property owner(s) do not reside in Diamond Valley.

If this School Support Notification is not returned to The Town of Diamond Valley, the individual owners' property will be assessable for public school purposes and the taxes on such property will be directed to the Alberta School Foundation Fund and redistributed on an equal amount per student basis, to public and separate school boards in Alberta.
