### Speak Out about the Downtown Cell Tower

The Town has been notified of an application to place a 35-metre cell tower in the heart of the historic Downtown District in the Turner Valley community of Diamond Valley. Town Council strongly opposes this location. The approving authority is Innovation, Science and Economic Development Canada (ISED), meaning the Town's objection alone will not be enough to stop it. **Community action is critical.** Residents are encouraged to write to ISED and the applicant to oppose this development before the deadline on April 4, 2025. ### Affordable Transportation Pilot Program for Low-Income Seniors

A new regional pilot project is making transportation more accessible for low-income seniors aged 55+ in Diamond Valley, Foothills County, High River, and Nanton. Funded through the Healthy Aging Alberta initiative, with support from the Government of Alberta and United Way, this one-year program provides affordable transportation options to help seniors attend medical appointments, social events, and community services.

Limited transportation options can be a major barrier for older adults who want to live independently, particularly in rural areas. Through collaboration with local Family and Community Support Services (FCSS), this initiative ensures eligible seniors stay connected with family, friends, and essential services. The Better Together pilot project is designed to enhance mobility, independence, and inclusion for seniors in these communities.

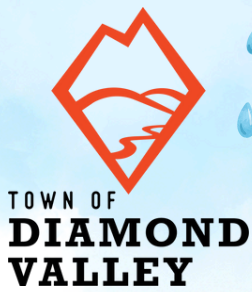

# MAYOR'S MESSAGE

## Mayor Barry Crane



As March brings the first signs of spring and a renewed sense of energy in our community, I want to address an important issue that impacts our community.

Council and I are very concerned about the proposed 35-meter (>100') cell tower in the heart of Turner Valley's historic downtown, a location we believe is unsuitable. While we strongly oppose this development, cell towers are federally regulated by Innovation, Science and Economic Development Canada (ISED), meaning the final decision is out of our hands. ISED will review public input before deciding, so if you have concerns, please submit them by April 4, 2025. While health concerns won't be considered, issues like heritage preservation, siting and location concerns, safety, and environmental impact will carry more weight. One project Council is enthusiastic about supporting is a new Disc Golf Course! Town Public Works / Civic Operations will be collaborating with the project's proponent this spring to clear a course near the Field of Dreams next to the river between the two communities. The Town will be purchasing the necessary baskets and amenities needed to support the course and we are looking forward to launching some discs this summer! The project team is currently looking for sponsors, with signage opportunities available in the course area for business, individual & family sponsors. We will also be looking for volunteers to help with the course building later this spring. This spring also brings significant changes to how waste will be managed. Thanks to the new provincial Extended Producer Responsibility (EPR) system, starting April 1, the costs of recycling will largely be borne by manufacturers, relieving some of the financial pressure from our community. Starting May 1, garbage collection will move to every two weeks, while recycling and compost (April – October) collection will remain weekly. Some residents may have a slight change to their collection days. These changes are being implemented in many communities to encourage better use of recycling and composting, helping extend the life of our landfill and reduce waste. Your patience and cooperation during this change is appreciated. To receive garbage day reminders, sign up at [DiamondValley.town/NotifyMe](https://DiamondValley.town/NotifyMe). We will provide more details as these changes approach.

Looking ahead, the Diamond Valley Parade and Festival will be happening on Saturday, June 7 this year. Council decided on September 18 to keep the parade route on the inner loop again this year, avoiding having to shutdown highway traffic and the need for contracting security/flaggers to manage those closures. There was great feedback from event goers and residents regarding the ease of travelling through town. I encourage everyone to visit and shop in the downtown Black Diamond community before and after the Parade prior to attending the Festival in Turner Valley. In an effort to move towards a cost-recovery model, January 1 was the start of the new utility rates and a \$2 paper billing fee, reflected on your current bill. To avoid the paper billing fee, sign-up to receive your bills by email at [DiamondValley.town/eServices](https://DiamondValley.town/eServices).

We understand that these changes may not be pleasant; but please keep interactions with staff respectful. Due to recent incidents of inappropriate behaviour, a 'Customer Code of Conduct' has been implemented. Please remember that frontline staff are not the decision-makers. If you have concerns, I encourage you to direct them to the CAO or Council through email, written submissions for the agenda, or by speaking during Question Period at a Council meeting.

I know the world stage is in a state of unprecedented change and we have many unknowns with how the tariff war will unfold, but we are a resilient town and I know we will face these challenges head on. Let's remember to support local at every corner store and market. Empower our fellow Albertans and Canadian businesses and be thoughtful of the hardships of others that may not be so obvious. Diamond Valley is growing and there is a lot of interest in our community from new investors, developers and most importantly new families. Our community spirit is attractive and our positive attitudes as a whole continue to make our community welcoming and warm. I'd like to thank everyone for making our town the best place in Alberta to raise a family, live, work and play.

Let's continue to embrace the changes and challenges we face with a spirit of cooperation and community. And as always, be safe, be kind, and be courteous.
