1. Introduction

Town of Diamond Valley 2024 Annual Report

This report highlights the progress, key achievements, and financial status of the Town of Diamond Valley over the past year. It aligns with Council's [Strategic Plan](#) and includes the Town's 2024 [audited consolidated financial statements](#) and a financial summary. The annual report outlines projects and activities undertaken in 2024 to inform residents, businesses, and stakeholders of the Town's ongoing progress and governance.

2. Background

The Town of Diamond Valley was officially established on January 1, 2023, through the amalgamation of the towns of Black Diamond and Turner Valley, forming Alberta's newest municipality. With a combined population of 5,341 ¹ (2021 federal census) and adjoining boundaries, the amalgamation represented a logical step - geographically, developmentally, operationally and politically. This unification positions the Town to navigate future growth more effectively, particularly as nearby Calgary - Canada's fastest-growing major city - continues to expand.

The amalgamation transition has taken place amid broader societal shifts, including post-pandemic supply chain disruptions, high inflation, demographic changes, rising living costs and housing challenges. While these factors are not the primary focus of this report, they provide important context. Many of the challenges the Town faces are not caused by amalgamation but are part of these broader trends affecting communities across the country. Amalgamation offers a more coordinated framework for addressing these challenges, even as its timing adds complexity to the transition.

Recent land annexation ensures long-term land supply. Access to outdoor recreation, major transportation routes, modern infrastructure, and a growing, skilled workforce make Diamond Valley a prime location for investment, living, and employment.

3. Mayor's Message

I am pleased to share with you, on behalf of Council, the Town of Diamond Valley 2024 Annual Report. The year was full of new challenges as we entered our second year as an amalgamated community.

In 2024, Council set its priorities on developing efficiencies and creating forward-thinking initiatives to prepare the Town for anticipated growth. Council announced a major step forward in shaping the future of Diamond Valley by embarking on the development of its first [Municipal Development Plan \(MDP\)](#). This long-term plan is designed to guide the Town's growth over the following 20+ years - focusing on land use, transportation, housing, and environmental stewardship - while staying true to the values that make the community unique. From thoughtful development to preserving natural landscapes and heritage, the plan represents a shared vision built together with the community. Council welcomes feedback as it works toward a thriving, connected, and resilient Diamond Valley.

At the same time, Council navigated some difficult budget decisions. Rising costs—such as a significant increase in RCMP services and infrastructure repairs—placed additional pressure on an already stretched budget. To keep increases as low as possible, a service level review was undertaken, with the goal of reducing or eliminating non-essential expenses. Cost-cutting measures were implemented where feasible in 2024, with a plan to implement fully in 2025. While the decisions have not been easy, Council remains committed to balancing financial responsibility with community needs.

Council thanks the community for being an active part of the conversation as we plan for a strong and sustainable future - together.

4. CAO Message

I am pleased to present the 2024 Annual Report for the Town of Diamond Valley. This year marked our second as an amalgamated community, and it has been a period of significant change and adaptation for our Administration.

In 2024, Administration focused on enhancing operational efficiency and implementing strategic initiatives to support the Town's anticipated growth. A key initiative was beginning the development of the Town's first Municipal Development Plan (MDP), crafted with community input to guide our growth over the next two decades. We also introduced new initiatives to enhance our operational efficiency, such as the implementation of [e-Services](#), offering residents the convenience of e-billing and optional automatic payments.

As we look ahead, we remain committed to building a strong, resilient, and connected Diamond Valley. I would like to thank our dedicated staff for their hard work, and our residents for their continued support and involvement. Together, we are shaping a bright future for our community.
